WARNING AGAINST RAGGING

“Ragging is certainly not a necessary stepping stone on friendship”. Friendship can be made and maintained even without ragging. It is for the youth themselves to find saner means of expressing friendship with their juniors. Respect forced out by ragging cannot be genuine respect. It is only a respect shown under duress, a semblance of respect tinged with fear of more ill treatment.

Putting a junior to shame certainly cannot make him respect his seniors. It will only kindle fear and a silent disdain for him at heart. Let this simple fact be known by all younger generation and protagonists of the customs.

The best solutions are that youth should themselves banish from their mind, the barbaric idea of ragging anyone or subjecting him/her to any torture or shame in its name”.

Govt. Order on Ragging

The Government of Tamil Nadu has banned ragging in Educational Institutions by passing a Government Order, “Tamil Nadu Prohibition of Ragging Act 1997” vide its order No.7 of 1997 dated 14-02-1997 which says that indulging in ragging will be punished as follows:

1. Imprisonment upto a term of two years and
2. A fine upto Rupees 10,000/- and
3. Student convicted for ragging will be dismissed from the Institute and shall not be admitted to any other educational Institution.

Hence, students are advised not to indulge in ragging and to rise up totally against this evil.

GENERAL GUIDELINES

1. Greeting the staff and fellow students by saying “**Good Morning / Good evening / Vanakkam**” is a desirable culture to be cultivated.
2. The morning session starts at 09.15 a.m. and ends at 12.45 p.m. The afternoon session begins at 01.30 p.m and ends at 05.00 p.m. **Late comers are not permitted to enter the college.**
3. Students are expected to **be regular** and **punctual** to all classes. Misconduct and violation of rules are to be avoided within the campus as well as in public places.
4. Students should not absent themselves without prior permission from the class coordinator / HoD concerned. In case of long absence, parents will be called for discussion.
5. Marks for Internal Assessment will be completely based on continuous assessment as prescribed by the university.
6. Students are expected to be regular in submitting their records and assignments.
7. **All students must wear their Identity Cards within the campus.**
8. **Dress Code** is formal shirt and full trousers for male students and Salwar kameez / Chudidhar with Dhupatta for female students.
9. Possession and use of all types of **cell phones** by the students are **banned** inside the Campus.
10. Use of **Internet** for purposes **other than academic** related activities is **banned**.

REQUIREMENTS FOR COMPLETION OF A SEMESTER

A candidate who has fulfilled the following conditions shall be deemed to have satisfied the requirements for completion of a semester.

Ideally, every student is expected to attend all classes and secure 100% attendance. However, in order to allow for certain unavoidable reasons such as Medical, participation in sports, etc., student is expected to attend atleast 75% of the classes during any semester.

Therefore, he / she shall secure not less than 75% of overall attendance in that semester taking into account the total number of periods (540 periods) in all courses put together attended by the candidate as against the total number of periods in all courses offered during that semester.

However, a candidate who could secure attendance between 65% and 74% only in the current semester due to medical reasons (hospitalization / accident / specific illness) or due to participation in the College / University / State / National / International level sports events with prior permission from the Principal shall be given exemption from the prescribed attendance requirement and he / she shall be permitted to appear for the current semester examinations.

Candidates who do not complete the semester (as per relevant clause), will not be permitted to write the University examination at the end of the semester and not permitted to attend during the next semester. They are required to repeat the incomplete semester in the next academic year as per the norms.

UNIVERSITY REGULATIONS

PROCEDURE FOR AWARDING MARKS FOR INTERNAL ASSESSMENT

For all theory and practical courses the continuous assessment shall be for a maximum of 20 marks. The above continuous assessment shall be awarded as per the procedure given below:

i) Theory courses:

Three tests each carrying 100 marks shall be conducted during the semester by the Department concerned / College. The total marks obtained in all the tests put together out of 300, shall be proportionately reduced to 20 marks and rounded to nearest integer. This also implies equal weightage to all the three tests.

(ii) Practical Courses:

Every practical exercise shall be evaluated based on conduct of exercise / experiment and records maintained. There shall be at least one mid-semester test. The criteria for arriving at the internal assessment marks (20 marks) shall be based on the University norms.

Every teacher is required to maintain a 'ATTENDANCE AND ASSESSMENT RECORD' which consists of attendance marked in each lecture or practical class, the test marks and the record of class work (topic covered), separately for each course. This should be submitted to the Head of the Department periodically (at least three times in a semester) for checking the syllabus coverage and the records of test marks and attendance. The Head of the Department will put his signature and date after due verification. At the end of the semester, the record shall be verified by the Principal who will keep this document in safe custody. The University or any inspection team appointed by the University may inspect the 'Records of attendance and Assessment' both current and previous semesters.

GENERAL PROTOCOL OF THE COLLEGE

1.0. DRESS CODE

- 1.1. All students shall wear neat, clean and decent dress. Girls shall wear salwar khameez / chudidar. Boys shall wear trousers and shirts.
- 1.2. Students shall wear shoes while attending the classes / laboratories/ workshops.
- 1.3. Students shall attend the laboratory and workshop classes in the prescribed uniform only.
- 1.4. While playing games or participating in sports, boys and girls may wear their appropriate sports attire and canvas shoes.
- 1.5. During educational tour, the students shall wear formal clothes that befit the culture and the background of the Institution and Management.
- 1.6. Students are not allowed to wear casuals or night wear outside the hostel premises.
- 1.7. Students found violating the dress code will be sent out of the class by the faculty concerned and will be made to face disciplinary action.

2.0 IDENTITY CARD

- 2.1. Every student admitted to the Institute will have to always wear an Identity Card issued by the Institution. The card must be surrendered at the time of leaving the Institution.
- 2.2. In case of loss of Identity Card students may make a written request to the Principal for a duplicate Identity Card. Such duplicate Identity cards will be issued on payment of Rs.500/- each. In case of damage, ID card can be renewed on payment of Rs. 150/-.

3.0 PUNCTUALITY

- 3.1. Students are required to be regular and punctual in attending classes / laboratories / workshops.
- 3.2. Students shall be in their seats in the classroom before the commencement of the classes, and shall observe proper classroom decorum.

4.0 CONDUCT AND DISCIPLINE

- 4.1. A Disciplinary committee is constituted with a view to manage students' discipline efficiently and effectively. The Disciplinary Committee shall have the power to directly call for an enquiry into any event affecting students' discipline on and off campus. They can summon any student(s) to appear before them in relation to an enquiry into any issue related to student discipline. The Disciplinary Committee shall also have the power to request any member of the administration or faculty to assist in the enquiry, including and not restricted to giving evidence of any event that occurred during the action under investigation and also to serve on the enquiry panel when relevant. It is the duty of all members of the teaching or non-teaching staff to comply fully in this respect. The committee shall have a sole discretion in deciding the culpability of any student(s) on the matter of discipline and shall recommend a suitable recourse.
- 4.2. Students are required to give an undertaking at the time of joining the Institute as well as at the beginning of the Academic Session to abstain from ragging, eve-teasing, quarrelling, smoking, use of alcoholic drinks, drugs and indulging in any other undesirable activity.
- 4.3. As a responsible member of the Institute, every student should maintain high standard of discipline, courtesy and behaviour both inside and outside the campus. Reports of complaints on behavioural lapses or indiscipline from faculty, non-teaching staff or from the public would be viewed seriously. Students are also expected to set an example through poise, politeness, harmony and integrity both inside and outside the Institute.
- 4.4. Students are strictly prohibited from smoking, consuming drugs and intoxicants. Playing cards, betting and gambling activities are totally prohibited and would be viewed as acts of grave indiscipline. Those who indulge in such activities will face disciplinary action such as Suspension / expulsion.
- 4.5. Ragging in any form is strictly prohibited. If any information is received about any student involved in any form of ragging, he / she will be expelled / dismissed from the Institute forthwith. The students are advised to take note of the standing Government Order in this regard, which has been displayed prominently in the Institute notice boards.
- 4.6. Indulging or supporting malpractice and misbehaviour will be considered undesirable and will be viewed seriously. The conduct of the student will be judged, depending on his / her good manners, decent behaviour, honest and sincere approach to their curricular, co-curricular and extra-curricular activities in the campus.
- 4.7. Students shall avoid saying / doing anything by word or deed that may disturb the unity and harmony of life not only in the Institute and Hostel but also outside the campus.

- 4.8. Students are forbidden from organising or taking part in strikes and demonstrations. No meeting of any kind, tea party, lunch, dinner or get-together shall be arranged in the Institute premises or outside without the permission of the Principal. Severe disciplinary action will be taken on those who violate this rule.
- 4.9. Students shall abstain from active participation in political and communal activities. Disciplinary action will be taken against any student / students who indulge in political / communal propaganda or organise fellow students in political / religious factions in the premises of the Institute or Hostel or otherwise engage themselves in group clashes.
- 4.10. Students should strictly desist from (i) use of rude language towards the staff of the Institute / Hostel (ii) assaulting or attempting to assault the staff or fellow students of the Institute.
- 4.11. Any student who has been convicted of any offence in the court of law will not be allowed to continue his / her studies in the Institute.
- 4.12. Students shall not indulge in any activity leading to the disruption of peace, discipline and dislocation of normal work in the Institute and Hostel premises.
- 4.13. Cases of serious indiscipline, repetition of minor indisciplinary acts will result in the name of the offender being entered in the Institute's Conduct Register or removal from the Institute.
- 4.14. In the Institute Cafeteria, separate wings have been earmarked for the use of boys and girls. They have to use only their respective wings.
- 4.15. During the class hours, students are forbidden from loitering along the corridors or roads. Students are required to spend their free hours in the library. They shall not loiter along the corridor or anywhere in the campus or disturb other classes at work. Any violation will be viewed seriously.
- 4.16. Bursting of crackers is forbidden within the Institute campus and the hostel during educational tours and even on festivals like Deepavali, Pongal, Christmas and New Year etc.
- 4.17. In the name of Holi Festival, farewell party and last working day etc. applying colour powder or sprinkling colour water on others is strictly prohibited.
- 4.18. Disciplinary action on students who violate any of the rules and regulations will include anyone or more of the following:
- i) Fine
 - ii) Suspension from attending the classes for a specific number of days. Such suspension period will be treated as days of absence.
 - iii) Not permitting to appear for the University Examination.
 - iv) Expulsion / Dismissal from Institute and / or Hostel.
- 4.19. No notice of any kind shall be circulated / pasted on the notice boards/walls without prior written permission from the Principal / HoD.
- 4.20. Cell phones are strictly banned in the campus, as the possession / use of them within the campus created several disciplinary problems of varied nature in the past. All the students, including dayscholars are not allowed to keep cell phones in their possession during the entire period of stay in the campus.

5.0. UPKEEP, CLEANLINESS AND SAFETY

- 5.1. Students shall strictly observe the safety regulations in the laboratories and workshops.
- 5.2. Students shall take care of tools, apparatus or other equipment given to them and shall preserve the cleanliness of the laboratories and the workshops.
- 5.3. Care should be exercised in handling the property of the Institute and any damage caused casually or wantedly will entail disciplinary / penal action and recovery of cost.
- 5.4. Students are prohibited from defacing or damaging any building or furniture or any asset or property of the institute.
- 5.5. Students are advised to switch off the fans and lights when they leave the classrooms.
- 5.6. Tea/Coffee/Snacks and any other refreshments served in the quadrangle should be taken within the quadrangle. Students are advised to throw the used disposable coffee/ tea cups or plates in the receptacle only. Students who violate this rule will be subjected to disciplinary action. Faculty shall bring to the notice of the disciplinary committee as and when they come across such incidences.

6.0. FUNCTIONS AND MEETINGS

- 6.1. Students are advised to actively participate in all the functions and meetings held in the Institute. When the students are called for attending such functions or meetings no student should stay back in the hostel and he/she is expected to leave the hostel well in advance, so as to reach the venue in time. They shall maintain perfect discipline and order while attending the functions/meetings. All the functions are likely to end before 7.30 p.m. As soon as the function is over, the students should disperse immediately.
- 6.2. In the valedictory function of associations and clubs, awards / certificates / mementos will be distributed in the presence of all the faculty members of the respective department. Students should not convene any separate farewell party either inside or outside the campus.
- 6.3. Students are not expected to leave in the middle of the proceedings of any meeting and not to be seen in any place other than the meeting venue.
- 6.4. Students are not allowed to shout, hoot or whistle during the functions like College Day, Hostel Day, and Sports Day or during Inter-collegiate competitions, Association meetings and Guest Lectures etc.
- 6.5. They are also advised to refrain from sitting on the pavements / stairs.
- 6.6. Outsiders should not be invited to any function without the getting prior permission of the Principal.

7.0. GENERAL

- 7.1. Requests, petitions, appeals and complaints of any kind need to be made in the first place to the Class Advisor/ Mentor/ Head of the Department concerned and not directly to the higher authorities.
- 7.2. In all academic or disciplinary matters, decision of the authorities of the Institute shall be final.
- 7.3. Students are expected to read the notice put up on the notice boards of the Institute /hostel.
- 7.4. Students are not allowed to come to the college by two wheelers.

8.0. TIPS FOR GOOD MANNERS / CONDUCT

- 8.1. Do refrain from hurting others by words or deeds.
- 8.2. Do consider others as brothers and sisters - an extension of your own self.
- 8.3. Do keep your rooms, surroundings and the campus clean and tidy.
- 8.4. Do participate in all the institutional activities in the campus enthusiastically.
- 8.5. Do refrain from smoking and consuming any intoxicants. It injures you and also others physically and mentally.
- 8.6. Do consider the whole campus as yours, and hence refrain from any activities harmful and destructive.
- 8.7. Do respect your teachers and all other staff members of the Institute. Respect given, begets respect.
- 8.8. Do maintain self-discipline in all your activities.
- 8.9. Above all, the whole campus is yours. After you leave, generations of students will have to use these facilities. Leave the campus as a better place for them. Make the best use of all the facilities for a successful future in your chosen field and for your personal development so that you can contribute to the development of the Nation.
- 8.10. Exchange of greetings with faculty members in the Institute and Hostels enhances the smooth relationship with them.

9.0. GUIDELINES TO THE PARENTS / GUARDIANS

- 9.1. Education is a joint responsibility. The parents and the members of faculty have to co-operate and co-ordinate their efforts in order to train the students on proper lines to maintain discipline and to inculcate diligence, honesty and courtesy among students. Parents are therefore requested to extend their full co-operation to the Institute authorities in all matters.
- 9.2. The parents can meet the Principal / Heads of the Departments on any working day regarding their ward.
- 9.3. Change of address of parents should be promptly intimated to the Institute in writing.
- 9.4. Whenever the presence of parents / guardians is needed, they should be present in the Institute upon request.

10. LIBRARY AND LIBRARY RULES

The library of JJCET has set a vision as “Right information to the right reader at the right time”. The library has 52,484 volumes of books under 21,771 titles. Also, it has subscribed to 440 e-Journals, 99 Technical journals and 40 magazines and 652 e-books.

1. Faculty, Staff and students of J.J. College of Engineering and Technology are the members of the library.
2. The Library is kept open on all working days & Saturdays

(Except on Sundays & National Holidays) from 09.00 a.m. to 07.30 p.m.

3. Books are issued between 10.00 a.m. and 04.30 p.m.
4. Books are lent to **U.G. students for 7 days** & for **P.G. students for 15 days** and can be **renewed** utmost **thrice** .
5. The books should normally be returned positively on or before the due date.
6. Fine is levied for late return of books.
7. The borrower should either replace the book or pay the price of the book.
8. The Library user must produce the **identity card** when entering the Library and it is used for all transactions of Books.
9. No user shall deface the library books by underlining, scribbling notes in the margins etc.
10. All users are requested to protect **library books as their own property**.
11. Books taken out of the shelves for reference should be left on the reading tables.
12. Students are **not allowed to carry anything inside** the library.
13. Personal belongings are to be left outside, at the entrance of the library.
14. Users found violating any of the library rules consistently will be reported **to the Library Committee Chairman** for proper action.
15. Periodical publications, Dictionary, Reports, Proceedings, Reference sources etc., will not, on any account be lent out.

12. RULES AND REGULATIONS FOR HOSTEL

“SELF-DISCIPLINE IS THE NEED OF THE HOUR” Management

Separate hostels for boys and girls are run by the management of the institution. Day to day administration of the hostels is looked after by a team of hostel officials, superintendents, deputy wardens and residential wardens. Hostel officials are appointed by the chairman from time to time.

Boys Hostel

There are two hostels, one for U.G students and other is for P.G. students with Cauvery water supply. The hostels are managed by the **Warden, Hostel Superintendents** and **Deputy Wardens**. In the U.G. hostel, there are 1500 students. We are using solar water heater for cooking and have well equipped kitchen. We have a **generator set in the hostel** for providing continuous power in case of power failure. We have one TV hall and sports facilities for students in the hostel. A doctor visits the hostel regularly to attend the students.

Girls Hostel

Girls’ Hostel is situated inside the college campus in an area of 27032sq.ft. of land. It can accommodate 700 students. Other amenities like water & Power supply, generator, mineral water for drinking and stationary, are provided to cater to the needs of the students and staff staying in hostel. The mess provides hygienic and nutritious food to the inmates. **Good security services are provided round (Vegetarian food only) the clock to ensure safety.** A lady doctor extends her service by visiting regularly.

12.1 Admission

- i. The right of admission to the hostel is reserved.

- ii. Application for admission to the hostel shall be made in the prescribed form.
- iii. At the end of each academic year, students willing to avail the hostel facility for next year, shall apply for re-admission.
- iv. After admission, no student shall vacate the hostel without prior written application of the parent/guardian and without the permission of the wardens.
- v. Room rent once paid will not be refunded.

12.2 Room allotments

- i. Allotment of room shall be made by the superintendent / deputy wardens and residential wardens.
- ii. Only after the payment of room rent, boarding charges, and other charges allotment will be made.
- iii. Resident must occupy the rooms allotted to them. Exchange of rooms will not be permitted.
- iv. Residents may be shifted from one room to another by the deputy wardens / residential wardens without assigning any reason thereof.
- v. The presence of residents in their rooms is a must between 8.00 p.m. and 6.00 a.m. (next day) on all days.

12.3 Study hour

Study hours will be observed strictly between 8.30 p.m. and 10.30 p.m. on all days except on Sundays. During the study hours pin drop silence and discipline should be maintained and disturbance to others will be viewed very seriously. All should remain in their respective rooms then. Mobile phones should be switched off during the study hours. Entering the hostel after commencement of study hours is strictly prohibited.

12.4 Attendance

Hostel students are expected to record their presence everyday, in the hostel through **Biometric Attendance System**, in the morning between 6.00 A.M. and 8.30 A.M. ; and in the evening 7.30 P.M. and 8.30 P.M.

12.5. Visiting Hours

The visiting hours for Parents and relatives of the hostel students
on regular days : 5.00 PM – 6.30 PM
on holidays : 10.00 AM – 4.30 PM

12.6. Communication through Mobile Phones

To avoid mobile signals, Jammers have been fixed in both boys and girls hostels. Hence mobile networking for communication will be enabled for the hostel students, only between 6.30 A.M. and 8.30 A.M. in the morning; and between 5.30 P.M. and 7.30 P.M. in the evening.

12.7 Other conditions

- i. All students of the hostel must abide by the rules and regulations of the hostel.

- ii. All should co-operate to maintain the peaceful atmosphere of the hostel.
- iii. Hostellers should follow the instructions of the deputy wardens / residential wardens scrupulously.
- iv. No student should stay in the hostel during class hours without prior permission of deputy wardens / residential wardens.
- v. Residents in a room are responsible for the breakage of the furniture of room and any damage should be brought to the immediate notice of the deputy wardens / residential wardens.
While vacating the room the furniture and electrical fittings should be handed over in good condition.
- vi. Use of electric heaters, electric iron or playing transistors is prohibited.
- vii. Use of liquor, narcotics, chewing gum, panparag, etc., is strictly prohibited.
- viii. Smoking is strictly prohibited.
- ix. Residents should not indulge in ragging freshers which is declared unlawful by both state and central governments.
- x. Clean environment, hygienic habits, neat and tidy garments will provide better atmosphere for living.
- xi. After 9.30 a.m. no resident is permitted to stay in the hostel during class hours unless he/she is sick which is to be reported immediately to the deputy wardens / residential wardens.
- xii. Electricity, water etc., shall be sparingly used. Residents are expected to switch off the electrical utilities and close the taps when they are not in use. The use of lap-top is meant only for education and not for entertainment.
- xiii. Accident prone materials like easily inflammable goods, sharp tools, lethal weapons etc., should not be kept inside the hostel rooms.
- xiv. Entertaining vendors of petty items inside the premises and convening of meeting without permission from deputy wardens / residential wardens are not allowed.
- xv. Residents are permitted to park cycle in the hostel premises at their own risk without hindrance to others.
- xvi. It is strictly prohibited to bring day scholars to the mess or to the room without prior permission of the deputy wardens/ residential wardens.
- xvii. Students who are going to their native place should enter in the register available with residential wardens.
- xviii. The hostel management does not own any responsibility for the loss of property left in the rooms, due to the negligence of residents in not properly locking their own belongings.
- xix. Birthday celebrations are not allowed inside the hostel.

- xx. Playing in the verandah / room is strictly prohibited.
- xxi. The hostellers are expected to give in writing their problems / difficulties experienced within the hostel to the deputy wardens / residential wardens.
- xxii. When need arises the residents are advised to meet deputy wardens / residential wardens and explain their problems.

12.8 MESS

“Wastage of food is a social crime”

1. Daily menu will be prepared by the management. In consultation with the hotel committee it may be periodically reviewed, and changed if necessary.
2. Wake up time: 05.30 a.m.
3. Mess Timing:
 - i. Coffee time : 06.00 to 06.30 a.m.
 - ii. Breakfast : 07.30 to 08.50 a.m.
 - iii. Lunch : 12.45 to 01.30 p.m.
 - iv. Dinner : 07.15 to 08.15 p.m.
4. Only vegetarian food is served in the hostel mess.
5. Day’s scholars and outsiders are not allowed for taking the food in the hostel under payment basis.
6. The residents are expected to come in decent dress. Late comers will not be entertained.
7. Altercation with officials and / or mess servants is highly undesirable.
8. Outside – persons will not be permitted to dine as permanent guests of any of the residents.
9. Complaint with regard to quality of food or service or any other matter connected with hostel has to be entered in the complaint book which is kept in the mess hall to be made to the deputy wardens / residential wardens in person.
10. Food and other eatables should not be taken to the rooms.
11. No one should wash their hands in the plate. The plates, tumblers etc., should not be taken to the rooms, for personal use.
12. Visitors with pass issued by hostel authorities only will be permitted to meet the girl students. Visitors even with a pass should not enter into the hostel rooms and they must meet the wards only in the waiting hall.
13. The hostel management has full powers to take action on those, who do not follow the rules and regulations of the hostel. The action may include the cost recovery, a fine, suspension or expulsion from the hostel or combination of these.

HUMAN RESOURCE DEVELOPMENT (HRD)

Building Tomorrow, Today

The Training and Placement Department of JJCET is responsible for career planning process, employability training and placement of students. The department partners with students in the process of career planning management. This starts with self- assessment and leads to identifying a career that meets individual goals.

Training and Placement Department is provided with complete infrastructure for effective functioning. The Department interacts round the year with corporate houses to explore the possibility of training and Job placements of students . Proper attention is paid to groom students of the industry not only in technical knowledge but also in personality, interpersonal skill & communication skills. Interactive seminars on the emerging technologies, Personality Development Programs, Career counseling and Industrial Visits are arranged to provide an excellent exposure to students.

The sincere efforts put into these activities has resulted in stupendous success with more than 400 of our students well placed in respectable Indian/Multi-National companies in the last academic year. All together more than 35 companies have recruited our students and the department is recognized by the industry as a source of reliable talent pool. A large number of companies visit the Institute for campus interviews regularly through out the academic year. Students and Parents are encouraged and advised to stay in touch with the Department for their best outcome. We believe in smooth integration of academic and industry is the key area to nourish talents.

JJCET has partnered with I.T. giant Infosys under their Campus Connect Program which is aimed at enhancing the employability of students. Industrial Visits are arranged with the aim of giving an insight into a complete process through which technology harnessed to produce output. The T&P Department takes lead in motivating, organizing such internships right from the first year.

CENTRE FOR ENVIRONMENTAL RESEARCH (CER)

The sustainability of our environment is under a constant and accelerating threat posed by human activities such as industrialization, technological advancement, population explosion etc. Hence the need for awareness on the environment protection is imperative. Consequently UGC has introduced Environmental Science and Engineering as a paper in all the Under Graduate Courses. It is obligatory on the part of technological institutions like JJCET to promote Research & Development and protect the sustainability of our environment and impart awareness on our youth. Environmental Research Center is established in JJCET with a primary objective of promoting research on important environmental issues confronting our country in general; and local people in particular.

PHYSICAL EDUCATION

The College maintains a full-fledged sports activity centre and provides the facilities for the following outdoor and indoor games. Basket Ball, Ball Badminton, Hockey, Chess, Kabaddi, Table Tennis, 12-Station multi-Gym, Badminton, Cricket, Foot Ball, Tennis, Volley Ball and Indoor Stadium.

TIES-2000 (Tamil Nadu Inter-Engineering Sports – 2000) was successfully conducted in our college during early 2000, when more than 15,000 sports persons from 75 engineering colleges in Tamil Nadu participated. We had another opportunity to host Ties 2012 in our campus which extended for over a period of 15 days (Feb. 15 - Feb. 29). Around 150 colleges across Tamilnadu participated enthusiastically.

Our college were the winners in Ball Badminton (men) and were the runners-up in Football (men) and Kabbadi (women). Our college conducted state-level football tournament, Mala Trophy.
